THE GUILDFORD OFF-STREET PARKING PLACES
(AMENDMENT) (NO.7) ORDER 2025**

NOTICE IS HEREBY GIVEN that Guildford Borough Council proposes to make an Order in exercise of its powers under Sections 32, 35 and Schedule 9 of the Road Traffic Regulation Act 1984, the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 and the Traffic Management Act 2004 and of all other enabling powers and with the consent of Surrey County Council and after consultation with the Chief Officer of Surrey Police, the effect of which will be to introduce –

Various car parks – Electric Vehicle Charge Point (EVCP) spaces

- (a) formalisation of the EVCP spaces so that, at all times, they can only be used, by plug-in electric and hybrid vehicles that are being recharged

Guildford Lido car park, Guildford

- (b) Renaming of car park from 'Lido car park' to 'Guildford Lido car park' and introduction of a permit scheme to prioritise space for visitors to Guildford Lido from Monday to Sunday 8am to 6pm

Kingston Meadows car park, East Horsley

- (c) removal of limited waiting time restrictions and no return same day restrictions that currently apply 6am to 6pm

Lawn Road car park, Guildford

- (d) extension of the operational and control hours of the car park from Monday to Sunday 8am to 6pm to Monday to Sunday 8am to 10pm

Millmead House car park, Guildford

- (e) extension of the operational and control hours of the car park from Monday to Sunday 8am to 6pm to Monday to Sunday 8am to 10pm

Sutherland Memorial Park car park, Guildford

- (f) removal of limited waiting time restrictions, no return same day restrictions and parking charges that currently apply from 6am to 5pm Monday to Friday
