A) General - all four licensing objectives	The Bolo and Brew Cafu00e9 will operate in a responsible and well-managed manner, promoting all four licensing objectives at all times. Staff will be trained in age verification (Challenge 25), responsible alcohol service, and how to deal with incidents in the appropriate way. CCTV will cover the cafu00e9 area and entry/exit points, with footage retained in the cloud via the Ring app. Measures will be taken to prevent noise. Alcohol will not be sold to intoxicated individuals, and children will only be allowed in age-appropriate areas under adult supervision.
B) Prevention Description	A CCTV system has already been installed on the premises and records 24/7 to the cloud via the Ring app. / Staff will be trained to refuse service to intoxicated persons or those acting aggressively. / An incident log will be available at all times.
C) Public Safety Description	Emergency exits are clearly marked. Fire extinguishers are in place and clearly marked. Occupancy limits will be in place and enforced.
D) Public Nuisance Description	Signs telling customers to leave quietly will be on display. Deliveries will be in normal operating hours (which they currently are for the cafe. Waste will be properly stored and removed regularly to avoid smells or litter (which is already is now due to the smooth running of the cafe).
E) Protection Of Children Description	A strict Challenge 25 policy will be in place. Only driving licence or passport will be accepted. All staff will be trained on this and the law.
