PUBLICATION SCHEME

This document is Guildford Borough Council's Publication Scheme, as required under Section 19 of the Freedom of Information Act 2000.

About the Freedom of Information Act 2000

This Act gives a general right of access to all types of recorded information held by public authorities, such as Guildford Borough Council. The Act lists the exemptions from this right as well as the obligations that the Council must observe when making information public.

Individuals already have the right to access information about themselves under the Data Protection Act 1998. However, the Freedom of Information Act 2000 effectively extends this right to all kinds of information held by public authorities.

One of the obligations placed on the Council is to adopt and maintain a "Publication Scheme". This must set out the categories of information that the Council will make available, the manner in which it will be published and whether a charge will be made for the information.

About Guildford Borough Council's Publication Scheme

The Head of Legal and Democratic Services has overall responsibility for the Council's Publication Scheme. The Information Rights Officer has responsibility for maintaining the scheme on a day-to-day basis.

The Publication Scheme lists all the categories of information that the Council is committed to making readily available to the public as a matter of routine.

When deciding what information should be included, the Council decided to adapt an "APLAWS" category list. APLAWS is an acronym, which stands for Accessible and Personalised Local Authority Websites. The APLAWS lists all of the most popular kinds of information that people usually search for on local authority websites. While the Council's Publication Scheme is not purely web-based, it is felt that this is a good indicator of the kinds of information that people want to know. Therefore, the Council has endeavoured to include those categories of information where possible.

This is very much a "first attempt" and it is envisaged that the scheme will evolve over time. A group of officers responsible for compliance with Freedom of Information in Surrey's local authorities will be meeting regularly with a view to adopting a consistent approach across the County. The group will also be sharing the results of ongoing consultations with the public and local businesses so that their schemes can be improved on an ongoing basis.

What Information has Guildford Borough Council Included?

Fourteen "main-categories" of information have been identified. Each category is further broken down into a number of "sub-categories". These are listed in Appendix 1 "Summary of Categories Included".

All recorded information that the Council produces which relates to those categories will be published as a matter of routine. However, there are some exceptions.

Documents Containing the Following Information Will Not Be Routinely Published, but May Be Made Available on Request

It should be noted that, whilst the Council will not routinely publish any information listed below, this should not prevent anyone from asking for it. The Council will still endeavour to release it or at least provide you with an edited version of the document, where possible. The Council intends to keep a record of all such requests in order to gauge public interest and, if appropriate, broaden the scope of information available under the scheme.

Documents not included at present:-

- 1. Internal working procedures: The Council has many documented working procedures relating to the categories of information set out under this publication scheme. At present, they will not be routinely published because, so far, there has been no evidence of public interest in them. We are concerned that to include internal working procedures will make the scheme unwieldy and difficult for people to find the information they want. However, the Information Rights Officer may be contacted to request this information. All requests will be logged so that procedures, which obviously appear to generate public interest, may be included in the scheme as appropriate. If the procedures contain any information exempted under Section II of the Freedom of Information Act 2000, an edited version may be released.
- **2. Security risks:** Any document, which contains information that, if published, could present a security risk to the Council's staff or property.
- 3. **Draft versions of documents:** Where the intention is to publish the final version later.
- 4. Officer Working Group and Councillor/Officer Working Group minutes: There are a number of working groups within the Borough Council. For example, representatives from key service areas meet periodically to discuss and recommend the Council's approach to issues such as e-government and the health and safety of staff. At present, the minutes from these meetings will not be published routinely under the scheme. This is because the outcomes are made public once the recommendations have been reported to committee. However, this arrangement may be reviewed if there appears to be public interest and the Information Rights Officer may be contacted to request it.
- **5. Superseded documents:** Old versions of documents that have been revised or updated will not be included in the Publication Scheme.
- 6. Documents containing information, which is exempt under Part II of the Freedom of Information Act 2000, including the following examples:
 - (a) Personal Information about other people, including correspondence files except where the subject has provided the Council with permission to publish it or it is necessary to publish the information in order to provide a Council service or otherwise comply with the law.
 - (b) Information provided in confidence such as that provided by protected informants.
 - (c) Court records and information covered by legal professional privilege.
 - (d) Information that the law says must not be published.

- (e) Information about specific contracts or commercial activities that the Council is not at liberty to publish.
- (f) Details of specific applications, such as for grants or licences, unless this is part of a statutory register.
- (g) Any information that could prejudice someone's health and safety or prejudice the prevention or detection of any crime.

What About Information Published by Other Organisations

It is important to note that Guildford Borough Council's Publication Scheme only lists the information produced by the Council. However, literature produced by other organisations, such as charities or central government is made available by the Council, via the Housing Advice Centre or other appropriate outlets. These are not listed in the scheme, as the Council does not control them.

The policy framework by which land-use planning decisions are assessed includes both Surrey County Council's Structure Plan and this Council's Local Plan and any subsequent supplementary planning guidance. All these constituent documents are known collectively as the 'Development Plan'. However, it is important to emphasise that responsibility for preparing and publishing these documents is shared between both the County and Borough Council.

How Are the Documents Listed in the Scheme Made Available?

This Publication Scheme document will be published in leaflet form, available from the usual Council reception points and outlets. It will also be published on the Council's website.

At present, the documents listed in the scheme are available either in hard copy format or on the website and, in some cases, both. Appendix 2 to the scheme lists all of the documents currently available and where they can be obtained. For example, some information is available from the Council's reception areas or from specific services. However, specific details are provided for all documents. Appendix 2 is subject to frequent change and is not included within this Constitution.

The Council will publish all of the listed categories of information using the Council's website. Other information will be available electronically in line with the Council's timetable for compliance with e-government.
